#### **Corporate Social Responsibility Policy (CSR)**

## Philosophy

# **CSR Objects**

The Company firmly believes that CSR is primarily the responsibility of the Company in relation to the impact of its decisions and activities on the society and also on environment through a transparent and ethical behavior which is:

- 2. In compliance with the law and is uniformly integrated and practiced throughout the Company.

#### Definitions

In the Policy, unless the context otherwise requires:

- 1. "Act" shall mean the Companies Act, 2013, including any modifications, amendments or re-enactments thereof,
- 2. "Board" shall mean the Board of Directors of the Company,
- 3. "Company" shall mean the Shree Ganesh Press n Coat Industries Private Limited,
- 4. "CSR Committee" shall mean the Corporate Social Responsibility Committee constituted by the Board of the Company in accordance with the Act, consisting of its Directors.
- 5. "CSR expenditure" means all CSR expenditure of the Company as approved by the CSR Committee, including the following:
  - A. Contribution to the CSR projects which shall be implemented and/or executed by the Company.
  - B. Contribution to CSR Projects which shall be implemented and/or executed by an agency.
  - C. Any other contributions covered under Schedule VII.
- 6. "CSR Policy" shall mean the present Corporate Social Responsibility Policy of the Company, which covers the activities to be undertaken by the Company as specified in the Schedule VII to the Act and the CSR expenditure thereon.

- 7. "CSR Projects" or "projects" mean Corporate Social Responsibility Projects/ activities/programs/ initiatives, instituted in India, either new or ongoing, and include, but are not limited to those undertaken by the CSR Committee as per the declared CSR Policy of the Company. Projects/ activities/programs/ initiatives undertaken in pursuance of normal course of business of the Company and Projects which benefits only the employees of the Company, and their families shall not be considered as CSR projects.
- 8. "Financial Year" shall mean the period beginning from 1<sup>st</sup>April till 31<sup>st</sup>March of every year.

Words and expressions used and not defined in this policy shall have the same meaning respectively assigned to them in the Act and/or Rules.

## **Scope Covered under the CSR Projects**

The scope of the CSR projects shall cover and include the following projects:

- 1. To promote education and to contribute for better education.
- 2. To help society to attain quality of life.
- 3. To promote, spread awareness specially related to health and hygiene amongst the women.
- 4. To develop green covers.
- 5. To undertake activities to overcome the socio-economic issues.
- 6. To contribution to the Prime Minister's National Relief Fund or any other fund set up by the Central Government for the purpose.
- 7. Any other activity covered under Schedule VII of the Act.

## Implementation

The Company may implement the CSR Projects by its own or through Agencies, subject to meeting the provisions of the Companies Act, 2013 and Rules thereon through Board of Directors.

# **Duties and Responsibilities**

- a. The Board shall monitor the implementation of the CSR Policy and CSR Plan.
- b. In discharge of CSR functions of the Company, the Board shall be directly responsible to carry out the activities under the act that may be required to be done by the CSR Committee in furtherance of its statutory obligations, or as required by the Board.

#### **Review Periodicity and amendment**

CSR Policy may be revised/modified/amended by the Board at such intervals as it may deem fit and unless it is revised, it shall be valid and enforceable.
